Township Administrator Mosca stated his recommendation is Bergdorfer. Options 3 & 4 of both contracts are not necessary. The total cost of the Bergdorfer contract is \$9,600. Mayor Van Pelt instructed Township Attorney McGuckin to stipulate in the Bergdorfer contract not to exceed \$10,000.

Township Administrator Mosca submitted a letter to the Committee to review regarding Telvue.

Mayor Van Pelt stated that sooner or later the Telvue contract has to be revenue neutral.

Township Administrator Mosca stated the town has contacted the diner, Sonic, Shop Rite and marina owners to help with the cost.

Committeeman Reilly inquired about the restroom facilities at Sands Point Park and if Township Administrator Mosca is comfortable that Phase I and Phase II in both proposals are consistent with each other.

Mayor Van Pelt stated the town only has to complete Phases I & II. Phases III & IV under both proposals are optional. Phases I & II for Bergdorfer is \$9,600 and for Yezzi is \$12,000.

Committeeman Reilly stated he just wanted to make sure that the town doesn't end up paying more later.
