Michele Rosen, 29 Bradley Beach, inquired if the town used the entire amount of money available from the 2007-2008 bank in this year's budget. Is the town setting aside \$270,000?

Mayor Kraft stated no, 1%, \$72,000.

Ms. Rosen stated this allows the town to increase spending next year by \$272,000. She feels that is not necessary and would like the Committee to vote against this ordinance.

Township Attorney McGuckin stated if the town gets a cut in State aid, the town may very well need that buffer.

PUBLIC COMMENT:

Ralph Avellino, 10 Central Avenue, inquired about Resolution 1009-173 Founder's Day Petty Cash Fund Application. Is this money for expenditures? Is this what Ms. Rosen was pointing out?

Mayor Kraft stated yes. By law this resolution is supposed to be passed every year. The town has missed it in the past. Ms. Rosen is pointing out all the town's inefficiencies, as minor as they are. Ms. Rosen has brought valid points tonight. Mayor Kraft will discuss with Mr. Mosca areas of the Administration side that need to be reviewed.

Mr. Avellino stated the Founder's Day Committee does not go out for bid when they purchase 2 x 4's for the Haunted Hayride. This money is raised by fundraising not tax dollars.

Mayor Kraft stated maybe the town should shop for office supplies somewhere other than Staples.

Deputy Mayor Reilly stated over the past year, the staff has been reduced. The town is now looking to improve the efficiency. Is it time efficient to be going around looking for quotes for small purchases? The success of the Founder's Day is a product of the men and women who work all year to raise the funds.

Deputy Mayor Reilly stated that the Founder's Day should be commended for their hard work throughout the year to raise the funds to make the Founder's Day possible for everyone to enjoy. They work hard to put a positive spotlight on the Community.

John Petrosilli, 11 Vessel Road, inquired if the resolution regarding water/sewer expenditures is going to reflect an increase.

Mayor Kraft explained the resolutions were to increase the temporary budgets to allow the Township to pay bills.

Michele Rosen, 29 Bradley Beach Way, stated the town must get two quotes, if the purchase is more than \$3,000, based upon the \$21,000 threshold. There is a \$29,000 threshold right now. Anything over \$4,000 has to have two quotes. The State law requires the town to aggregate similar things.

Ms. Rosen stated at the last meeting she brought up the question about the resolution expressing dissatisfaction with Assemblymen over their vote against the Mortgage Stabilization Act. It is solely for people who are in imminent danger of foreclosure. She inquired if Mr. Lachawiec applied for this loan.

Committeeman Lachawiec stated the term was the HASP Program. It is his understanding if someone's income dropped to a level, where their mortgage was 30% more than their monthly income, they may be eligible for the program. Committeeman Lachawiec did not say he applied. He asked if he could be included in the program. He has not heard back from the bank.

Ms. Rosen inquired with Committeeman Lachawiec if he lived in Grand Bay Harbor and owns two boat slips.

Committeeman Lachawiec stated he does not own two boat slips.

Ms. Rosen stated there is one from the foreclosure list that the town auctioned at a sale. Committeeman Lachawiec was the highest bidder. What is the status of that slip.

Township Attorney McGuckin stated the township did a public bid of a number of parcels of property in a public bidding process two years ago. The slip is one of the items in tax foreclosure. The township took title to it. A lot of those properties went to sale through an auctioneer. The slip is one of those items. There are some title issues that still have not been resolved. There is a contract to convey the slip to the highest bidder at the time. The township has a deposit. The Township is in discussions with the condo association to complete this transaction.

Ms. Rosen inquired if Committeeman Lachawiec is using the boat slip.

Committeeman Lachawiec stated yes.

Motion to close to the public was moved by Committeeman Lachawiec, seconded by Deputy Mayor Reilly.
