# **Committee Reports**

Mayor – Dennis F. Tredy

Founder's Day is Saturday, May 24, 2014. The events will start at 9:00 am with the vendor fair, which will include crafters, food, flea markets, non-profit vendors and local bands on stage. Starting at 9:30 am there will be free children's rides and registration for the pet parade. Prizes will be awarded for the most unique animals, best dressed, funniest and many more. There will be a cupcake decorating contest for different age categories from 4-17 years old, followed by a cupcake eating contest. Founder's Day will conclude with fireworks over Barnegat Bay at dusk.

The United States K9 Association Region 15 Police Dog Trials will be on May 31, 2014 and June 1, 2014. This is the second time the US Police K9 event has been hosted by the Township of Ocean. Everyone is encouraged to attend. The location maps will be posted on the website, emailed to Township residents and available for pick up at Town Hall. Township of Ocean Police Officer James Capaccio and his K9, Kavar, won two major awards last year.

Deputy Mayor – Tina Wetter No report tonight.

Committeeman – Joseph Lachawiec

Permits were issued in 2011, to build an extension of Volunteer Way. The Township has been pushing for Volunteer Way for many years.

Deputy Mayor Wetter discussed the Township will need \$5-6 million to build the extension. The Township does not have that money right now.

Mayor Tredy discussed Superstorm Sandy set the entire region back. The Township's main concern is taking care of the people in town, making sure resident's garbage is picked up and making sure the Policing is done properly. Volunteer Way is an important project but will unfortunately have to take a back seat at this time.

Township Administrator Breeden discussed a Master Developer was supposed to handle the Volunteer Way project. Since the downturn in the economy, the possibility of a Master Developer taking on the project is challenging. Permits were issued in 2011-2012. There is a duration associated with any permit.

Township Attorney McGuckin will see if the Permit Extension Act will apply to Volunteer Way.

#### **Administrator Report**

Administrator - David Breeden

Ordinance 2014-2, Second Reading, Public Hearing. The Township of Ocean and practically every other municipality in the state of New Jersey adopts this ordinance every year. There are two types of CAP's placed on municipalities. One is an appropriations CAP. The second is a tax levy CAP, which was instituted in 2010. The appropriations CAP was developed back in the mid 70's. This ordinance allows the Township to go up to 3.5% of appropriations. What is not used will go into the CAP bank, which can be used for two future years.

Ordinance 2014-3, Second Reading, Public Hearing, is a bond ordinance for \$6.6 million for water/sewer improvements along the Waretown bay front, Seneca Boulevard, 11<sup>th</sup> Street, and Skipper's Cove finger streets. This will be the most ambitious public works project in Waretown history. Approximately \$4.1 million is allocated for sewer and \$2.5 is earmarked for water.

Ordinance 2014-4, Second Reading, Public Hearing, combines the Founder's Day Committee and the Recreation Committee into a new Committee called the Ocean Township Recreation and Special Events Committee.

Resolutions 2014-179, 180 and 181 acknowledge the sale of bonds for either completed or ongoing water/sewer projects on Montclair and Hornblower. The Township has taken advantage of the state Environmental Infrastructure Trust (EIT) program with respect to financing water/sewer improvement work. The Township issues the bond and the EIT provides the funding mechanism to pay off the bond. Resolution 2014-179 and 181 deal with Montclair Road North and Resolution 2014-180 deals with sewer work on Hornblower that has been completed.

Resolution 2014-182 is an approval for the Township to submit applications to the state of New Jersey for various post-Superstorm Sandy recovery grants. There are several different types of grants in the amount of \$225,000. The Township has successfully completed the first round of grants for \$30,000. This process will help the Township become more sustainable in future storm events.

Resolution 2014-183 authorizes participation in the countywide hazard mitigation plan. As a result of Superstorm Sandy, the County became aggressive with completing the Hazard Mitigation plan. The countywide plan has been completed. The Township of Ocean is part of that plan. The adoption of this resolution will open the door for the Township to apply for various federal and state grants dealing with mitigation.

Resolution 2014-188 authorizes the hiring of a Construction Technical Assistant to replace the outgoing full-time employee that has departed the organization.

Resolution 2014-202 is for Schedule C with the County of Ocean. This resolution is adopted every year for various cold patch, asphalt and other highway maintenance materials and supplies.

# **PUBLIC PORTION:**

John Petrosilli, 11 Vessel Road, inquired why the three bond ordinances were split up.

Township Administrator Breeden discussed the NJ Environmental Infrastructure Trust requires sewer and water projects to be separate. There are two resolutions for water/sewer work on Montclair and one resolution for sewer work on Hornblower. These resolutions are a formality acknowledging the state sold the bonds and attached are the payment schedules associated.

Mr. Petrosilli inquired if Bay Haven and Sands Point will have water/sewer replacement as well.

Township Administrator Breeden discussed there is an extensive list of projects needed, as a result of an engineering study performed by the MUA in 2005 and 2006. The Township determined which repairs were more urgent, according to traffic volume and past repairs. Montclair had numerous emergency water main breaks in the past.

Eileen Doyle, 243 11<sup>th</sup> Street, discussed the last time Volunteer Way was discussed, the amount was \$1 million. Now it is \$6 million.

Township Administrator Breeden discussed it was never \$1 million.

Committeeman Lachawiec discussed in 2008 it was \$2.5 million. As time goes on, there were snake studies and snake tunnels discovered that increased the cost. That is why Wawa decided not to enter into negotiations to purchase the Thirsty Mallard, due to the possibility of Volunteer Way not getting built in 2008.
