**STATEMENT**: Pursuant to the provisions of the New Jersey Open Public Meeting Act, adequate notice of this meeting was properly provided by sending a copy of the Notice of Meeting to two newspapers, The Asbury Park Press and the Press of Atlantic City. The Notice was posted at the office of the Township Clerk

Mayor Collamer asked the audience to remain standing for a moment of silence for the passing of Freeholder John C. Bartlett. John Bartlett was a very good man, a great Freeholder and a good friend to the Township of Ocean municipality.

### **Presentation**

Committeeman Baulderstone presented a plaque to Mayor Collamer thanking him for his service on the Township Committee. Daniel Collamer was appointed to the Committee December 10, 2015 – December 31, 2018, served as Mayor 2018, in recognition and sincere appreciation for your three years of service, dedication and outstanding leadership to the Township of Ocean and its residents, presented by the Township Committee of the Township of Ocean.

Mayor Collamer discussed he would be happy to assist the Township Committee with anything they need.

#### **Committee Reports**

Mayor – Dan Collamer

Ordinance 2018-19 - 2nd Reading – Public Hearing. Tonight is the Public Hearing regarding a Redevelopment Project. The project was heard at the Redevelopment Meeting on September 25, 2018 and was approved. The Redevelopment Plan was reviewed and approved at the Planning Board on December 8, 2018. The building location is on the corner of Route 9 and Clearwater Drive. The building will have a complete overhaul of the property and the building. The property behind the project will be combined as one block and lot. The sidewalk will be brought over from the CVS to Clearwater Drive with the streetscape.

Ordinance  $2018-20 - 2^{nd}$  Reading – Public Hearing. The Public Hearing tonight is to be in compliance with the New Jersey State Law Uniformed Shared Services and Consolidation Act. When a Township shares a Construction Official and Subcodes, their fee schedule must be the same. The Township is not in compliance with the law and is now rectifying this situation.

Ordinance  $2018-21-2^{nd}$  Reading – Public Hearing. The Public Hearing tonight is regarding bulkheads. There have been discussions regarding bulkheads and permitting. During my time on the Township Committee this matter has been brought to my attention on several occasions. Bulkheads do not fall under the UCC Code. These changes are being made to continue with compliance for permits of bulkheads and efficiency within the process.

Resolution 2018-300 authorizes the execution of the Ocean County Schedule C Agreement. This document has to be in place for the Township to obtain items from Ocean County. This includes basins, salt and paving if necessary. The Township is billed for items used but needs to have the agreement signed to be part of the program.

Resolutions 2018-302, 303, and 304 authorizes a lien to be placed on the properties for failure to abate property violations.

Resolution 2018-309 authorizes a house account at Tractor Supply for the Township. It is important for the Township to use local businesses to purchase necessary items.

NJ DOT – Roadway Improvement Program – Sheridan Street, Illinois Avenue, Adriatic Avenue and portions of Michigan Avenue, Kennedy Drive, Lincoln Drive. The project is scheduled to be completed with all storm drainage by the end of this week. All trenches will be paved and shoulders restored for the winter. Roadway construction will be completed in the Spring 2019.

#### Committeeman - Ken Baulderstone

Resolution 2018-299 authorizes appropriation transfers within the 2018 Budget. As per New Jersey State Law transfers are allowed during the last two months of the year.

Resolution 2018-305 authorizes the Tax Collector to cancel the tax sale certificate for 96 Bryant Road. The Township has taken ownership of the property. In accordance with Litho Tech's bankruptcy filing the court authorized a redemption of the tax lien. Upon cancellation of the Tax Sale Certificate, the Township will be able to obtain the final title insurance policy.

Volunteer Way Update. The Township has submitted the permit for Volunteer Way to the New Jersey Department of Environmental Protection for their review and comments.

Senior Advisory – Holiday Lunch and Speaker. December  $17^{th}$  at 11:30 am – Dr. Hager from Hackensack Meridan will be coming to speak. The luncheon will be immediately following. Please RSVP to Jeanne Broadbent in Recreation if you would like to attend.

Town Tree Lighting and Sundaes with Santa. Thank you to all who came to this event. There were 180 people who attended. We would like to thank all the volunteers who assisted in making this a great town event. Having Santa Claus, Frosty the Snowman and the Grinch attend made for an exciting evening for all. The DJ did a great job teaching the children dance moves. We would like to thank members of the

Special Events Committee, Fire Department, Police Department, Department of Public Works and staff members.

# Chief of Police - Michael Rogalski

Chief Rogalski read the November 2018 Police Report. The Police Department handled 3,671 calls for police service, 4 abandoned 9-1-1 calls, 35 alarms were activated and responded to, 28 animal complaints were handled, 1,867 business and property checks, 2 criminal mischief acts were investigated, 17 domestic violence incidents, 12 disabled vehicles were assisted, 67 first aid calls, 36 general complaints, 28 motor vehicle accidents, 432 motor vehicle stops of which 106 were issued tickets, 4 juvenile complaint, 3 psychiatric evaluations (PESS), 32 persons were arrested on various warrants, 2 shoplifting incidents, 47 suspicious persons, 6 thefts from residences or commercial properties and 1 theft from a motor vehicle were investigated. A full list of this activity is listed on the website.

Regarding speeding issues in the Township, the JAMAR speed data collection device was placed on Barnegat Beach Drive between November 4, 2018 and November 14, 2018. A total of 85,550 vehicles were recorded over ten days. The average speed was 37mph, with no significant difference in direction. The speed limit there is 35mph. That machine will be place in that area again, as the summer months approach to see if there is any change in average speed with marina traffic. That machine was also placed on Seneca Boulevard, east of 7<sup>th</sup> Street, from November 16, 2018 to November 30, 2018. 25,891 vehicles were recorded. The average speed was recorded at 29mph with no significant difference in direction.

From October 21-December 8, 105 hours of traffic control details were conducted, which included monitoring traffic along the detour and various locations within the Township for speeding. There were 232 incidents, 74 motor vehicle stops, 94 warnings and 7 tickets were issues.

In reference to the detour, between October 5, 2018 and December 4, 2018, 23 motor vehicle stops were conducted, specifically for large trucks crossing over the bridge, and had them turn around.

New jackets were purchased for the patrol officers. There is a significant change in the uniforms, which include the outer carrier and a two-part jacket, one for underneath and one for on top. The vest would go on top of the jacket and there is another jacket that would go on top of the vest, if needed. There have been no complaints of the outer carrier.

Deputy Mayor LoParo arrived at 7:13 pm.

#### Deputy Mayor - Ben LoParo

Resolution 2018-301 authorizes the submission of the Municipal Alliance Grant for the July 1, 2019 – June 30, 2020 in the amount of \$21,786.00.

Resolution 2018-307 authorizes Class II Officer Gregory Mezzanotte has completed his Field Training Program and at the recommendation of the Chief of Police will be paid \$15.00 per hour for hours worked.

Resolution 2018-308 authorizes the hiring of a Part-Time Dispatcher. Katie Paone has been interviewed and passed the background check. The Township looks forward to having her start training in dispatch.

Resolution 2018-310 authorizes the signature and approval of the Police Dispatchers (Telecommunicators) contract under the Teamsters Local Union No. 676 affiliated with the International Brotherhood of Teamsters. This is a 5 year contract that will start on January 1, 2019 end on December 31, 2023. The employees will receive a 2% increase each year of the contract.

Police Department Vehicle Purchase. During last month's meeting, it was discussed that the Township would be purchasing a Ford Eco Sport for the Police Department. After further review of the Township vehicles, the Township will purchase the vehicle and place it at the Construction/Zoning Department and the Explorer from the Construction Department will be transferred to the police vehicle pool.

Municipal Alliance. The Township Food & Toy Drive has been completed. The toy and gift cards were distributed to over 40 families. The food drive distribution to the residents will take place on December 21<sup>st</sup>. The Township would like to thank all residents and businesses who donated toys and food. This would not be possible without the donations. There are many who donated gift cards. Greenbriar's Men's Club donated \$1,000 worth of gifts for the toy drive and will provide 64 complete meals for distribution to families in the Township. So many others gave donations but requested to be anonymous.

Township Administrator Ambrosio discussed the funds are coming from one account and spread out to other accounts where needed. The "From" column amount equals the "To" column amount.

Township Attorney McGuckin discussed in the last two months of the year, every Township has the chance to transfer monies from certain line items to other line items. The budget anticipates what expenses are going to be in each department and budget for that. At the end of the year, the Township sees that more was spent in one line item or less in others. During the last two months of the year, the Township can transfer between those line items to make sure the budget is equal for the year. The "From" accounts are monies left in those accounts that were not spent and will not be spent by the end of the year. The "To" accounts are short and spent more than anticipated, therefore, money is taken from other line items and transferred to where the money is needed. It has to equal at the end of the year.
