# **Presentation**

Jeff Dostal – Site Vice President – Holtec Decommissioning International Check Presentation Playground Equipment – Corliss Park

Jeff Dostal, Holtec Decommissioning International, discussed he expected to work at Oyster Creek for two years and four years later, he is still here due to the community and the area. He loves it. That is one of the things Oyster Creek and Holtec push the most is being good neighbors. That is why Holtec is donating to the Corliss Park Playground Equipment and continue to support First Responders of Waretown and will continue to donate. If the Township of Ocean ever has any questions, they can contact Mr. Dostal anytime.

Holtec prides itself on open and transparent communications, making sure the public has all the knowledge to not be afraid of what is going on at Oyster Creek. For decommissioning, one of the first steps Holtec did was remove all the fuel from the reactor and put it into the spent fuel pool. All that fuel is then transferred to dry storage and it is on the Independent Spent Fuel Storage Installation (ISFSI) pad right now. It has been there for two years and is very stable. The high level waste was removed from the reactor, placed in canisters and also put on the ISFSI pad. Those are being maintained and protected there until the Governor picks them up and stores them in Yucca Mountain Nuclear Waste Repository or a repository that Holtec is going to build in New Mexico.

Holtec also started taking apart the internals of the reactor, which should be complete by the end of this week. The reactor will be void of its internals. Those were cut up, packaged, boxed and disposed of. The disposal site is in Texas. That is where most of the waste goes. Holtec also prides itself on doing things different. Holtec does things in an innovative way and a better way. Other decommissioning companies, Excelon and Vermont Yankee, are in a pattern of ripping. They take everything apart and ship it for waste. Holtec is recycling about 24%-25% of the waste. That is a lot. There are tens of millions of pounds that come out of that site to date, and 25% has been recycled. Mr. Dostal thinks Holtec can improve to 40%-50%. That is good for the environment.

The second phase is demolition of buildings and structures. The demolition is complete, which includes about 54 structures, removing tanks, etc. There are still three major structures that have to come down. Those are the reactor building, teraton building and the radioactive waste building. Holtec is working on the new radioactive waste building, then will move on to the reactor building. Those are larger structures

and will take more time. The next step is characterization and taking care of the property. Holtec looks to release the site for open use, which is characterization. Characterization Phase I includes remediation of a property for oil or any type of spills. That part is complete. The nonradioactive remediation of the site is complete. Characterization is a study of the property, taking samples, water samples, deep core samples and making sure it is releasable. The target date is 2028 to complete remediation and open the site for reuse.

Mayor Baulderstone inquired if 2028 is the first year when any of the property will be perhaps sold off.

Mr. Dostal discussed 2028 is the first year Holtec will start site leveling and grading. Holtec is still looking at different use options. A battery company has talked to Holtec about putting a site there. Solar power is coming through the discharge canal and establishing a connection into the Atlantic City Electric line. If the Township has any questions or concerns, please contact him.

Mayor Baulderstone thanked Holtec for the support of the playground equipment.

Township Administrator/Clerk Ambrosio discussed Holtec has submitted a check for \$10,000 for the playground equipment at Corliss Park Lake & Recreation Area.

Resolution 2023-84. The Township will be holding the annual Fireworks on May 28<sup>th</sup> at dusk over the bay. This resolution is authorizing the cost and guaranteeing the date and rain date for 2023.

Resolution 2023-85. The Township Committee is again applying for grant funding from NJ Department of Community Affairs (NJDCA) in the amount of \$100,000.00 for reconstruction of the existing sport court into pickleball courts at Toumey Park. This funding would be used to upgrade the court to Pickleball courts. Pickleball, over the past four years, is one of the fastest growing sports in America. Pickleball is being played competitively in High Schools and colleges throughout the country and appears on the Tennis Channel. Pickleball is gaining popularity because it is easy to play, low impact and appeals to a wide range of people from kids to senior citizens.

Resolution 2023-88. The Township has been informed that it has been awarded a grant for the 2023 Municipal Aid Program Improvements to Beacon Drive and Nautilus Road in the amount of \$418,540.00. This resolution is authorizing T&M Associates to continue the work on this grant and oversee the project.

NJ Department of Community Affairs (NJDCA) Local Recreation Grant Program FY 2021. The project has been awarded to Down to Earth Landscaping. Contracts have been signed and bonds posted. The contractor is having the path alignment and limit of disturbance surveyed and will begin clearing work shortly. The project will be completed within 4-6 weeks once the work begins, the schedule is dependent on the weather.

Resilient NJ – Township of Ocean –  $3^{rd}$  Public Meeting. The Resilient NJ Municipal Assistance Program supports municipalities in integrating climate change science into their planning and decision making, creating a future that is more resilient to the effects of extreme heat, sea level rise, coastal storms, extreme precipitation, and other impacts of climate change. The  $3^{rd}$  public meeting will take place virtually on February 27<sup>th</sup> on Zoom 5:30–7:00 pm. The information will be sent out shortly with the link to the meeting on the Township e-mail, Facebook, website, and TV channel.

### Chief of Police, Michal Rogalski

Chief Rogalski read the December 2022 Police Report. The Police Department handled 4,058 incidents for police service, 4 abandoned 911 call, 32 alarms activated and responded to, 20 animal complaints, 2 residential burglaries, 2,550 business/residential checks, 3 acts of criminal mischief, 3 domestic violence incidents, 12 verbal disputes/harassment complaints, 14 disabled vehicles, 2 drunk driving arrests, 101 first aid calls, 21 motor vehicle accidents, 238 motor vehicle stops, 2 juvenile complaints, 7 psychiatric evaluations, 10 persons were arrested on various warrants, 47 suspicious persons and/or vehicles were investigated and 5 thefts from residences or commercial properties were investigated. Shawn Denning Jr., 92 Morey Place Road, inquired if the Governing Body has thought about revisiting the parking ordinance. There are a lot more parking signs throughout the County, stating parking lots are patrolled by towing companies, indicating there is a parking problem. Mr. Denning discussed people who live in various developments have complained about parking.

Township Administrator/Clerk Ambrosio discussed she has never received a complaint about parking.

Mr. Denning discussed the Township needs more spaces allocated for multibedroom units. Two bedroom homes have a least two cars and children of driving age need cars. That is 3-4 cars for a 2-3 bedroom dwelling. The Township should make the parking standards higher.

Mr. Denning discussed Morey Place Road. The Department of Public Works (DPW) came out on the New Holland tractor and graded the road. DPW has not been back. The road has not been inspected. If a vehicle drives 10 miles per hour down the street, the suspension will bottom out. Mr. Denning discussed he requested grading, no stones, in December through the Citizen Problem Reporter. Mr. Denning discussed he would like Morey Place Road on a prescribed routine maintenance.

Mayor Baulderstone discussed he visited the road and DPW went out and did work on the road. After a storm, potholes formed in the area of Route 532. DPW laid materials and as recently as two days ago, none of the potholes were there. There is a plan of doing a run of about 25 feet from Wells Mills Road into Morey Place Road. That will be included in a bid process.

Mr. Denning requested the next time it rains, DPW grade in front of 96 Morey Place Road the day after the rain.

Mayor Baulderstone discussed he will look at it tomorrow. The last time he went out, there were no potholes further along in the road.

Township Attorney Dasti discussed the parking ordinance. The Township complies with the Resident Site Improvement Standards (RSIS) requirements. That is a State traffic and engineering code. Any Planning or Zoning Board conditions of approval will comply with RSIS. The Township is meeting the State requirements.

Jason Worth, Township Engineer, discussed he will look into if the standards have changed.

Mr. Denning inquired if Townships can require more parking than the state standard.

Township Attorney Dasti discussed State standard is the standard. If the Township were to take a more restrictive approach it could, hypothetically, open up the Planning and Zoning Boards to litigation that is arbitrary capricious.
