Thank you for coming to the Township Committee meeting this evening.

BLOC Medical Cannabis dispensary. The Medical Cannabis dispensary is open. There have been no issues and all who have gone in to obtain their medical cannabis have nothing but nice things to say about the professional staff and their knowledge. At this time, the Township does not receive any additional taxes due to you cannot impose additional taxes on medical cannabis sales.

Bank in Town Center. There is a secondhand dealer in the old Ocean First Bank. All permits and inspections are complete and this business is open.

Joe's Bagels will be open Thursday, July  $20^{th}$  from 6:00 am – 2:00 pm.

Saladworks is currently looking at signage and will be handing in permits shortly for the change of use at the old GNC Store.

Municipal Alliance with the Police Department. A drive-In movie is planned for September 29<sup>th</sup> on the Frederic Priff field. The movie has not been picked at this time.

#### June 2023 Construction/Zoning Report

Zoning. 43 applications approved, 17 applications pending review and 3 denial applications.

Code Enforcement. 26 Notices of Violation, 6 Second Notices of Violation, 9 properties abated their violations and 1 Lien placed on property–48 Bay Parkway.

Construction. 53 Permits Issued, 14 Permit updates, 57 Certificates of Approval, 2 Certificates of Occupancy, 1 Continued Certificate of Occupancy, 2 Notices of Violation–work without permits, 2 Notices of Violation–Fail to call for inspections.

Ordinance 2023-15 Bond Ordinance. Tonight is the public hearing on this bond ordinance for multiple projects. The Township did receive a Grant from the NJ Department of Transportation (NJDOT) in the amount of \$418,540.00 for work to be completed on Beacon Drive and Nautilus Drive. The NJDOT reimburses the Township once the work is complete. The Township will also include drainage work on the road at this time. This is not covered by the grant. Also, repairs to a bulkhead on Hornblower Drive are included, as well as the repairs to the front steps of Town Hall. The stairs are in disrepair, as well as the sidewalk and curb. This item has been written up by the insurance company for replacement.

#### Project Updates

Joe's Bagels has passed all inspections, received their Certificate of Occupancy on Friday and are opening on Thursday.

Zano's is opening their pizza restaurant on Thursday.

Ovations Dance Studio is expanding into the unit next to their studio. Their Certificate of Occupancy for the additional space was issued on July 11, 2023.

The Historical Society and Museum has a program every Friday during the summer. This Friday, Jack Henderson will be speaking about the Lighthouse Camp. Attendees can browse the museum after the program. Flyers listing all Historical Society Summer Programs are in the back of the room.

#### Mayor - Ken Baulderstone

#### Good evening,

Ordinances 2023-12, 2023-13, 2023-14. Tonight is the public hearing on these three ordinances that update ordinances in the codebook at this time. The updates clarify wording in each ordinance and fees.

Independence Day Celebration. The 13<sup>th</sup> Annual Independence Day Celebration took place on Saturday, July 8<sup>th</sup> at Corliss Park Lake and Recreation Area. The Township Committee and I would like to thank the members of the Waretown Volunteer Fire Company, Ocean Township Police Department, Waretown Volunteer First Aid, CERT Team, Department of Public Works, as well has the people who participated, Barnegat American Legion Post 232, Color Guard, Greenbriar Glee Club, Pastor Dawn, Waretown United Methodist Church Bell Choir, Greenbriar Men's Club, Adele Shaw, President of the Waretown Historical Society and all the groups, organizations and volunteers who help make this event a success. Without their hard work and dedication, this ceremony would not be possible.

Utility Sewer Main Repair – Englewood Avenue. The Township is obtaining quotes for the emergency repair to the manhole and adjacent pipe on Englewood Avenue. There will be noise from dewatering prior to the repair, due to the pipe being so low in the ground. The Township is accepting quotes from contractors at this time. As soon as all quotes are received, the project will be awarded due to this being an emergency repair.

Film Ready New Jersey. The New Jersey Motion Picture and Television Commission has developed a program where local communities, towns and counties can become certified as film-ready. Certification is a program that educates municipalities on the basics of motion picture and television production and enables cities and towns to effectively accommodate on-location filming and market their communities as filming destinations, which can be very lucrative for local businesses. While potentially creating some short-term inconvenience to residents, New Jersey has introduced tax benefits for companies filming in New Jersey.

This Film Ready New Jersey program demonstrates to the film production industry that a municipality is enthusiastic about film making and film-ready. Some of the benefits of being certified film-ready, are locations are tagged as a film-ready communities in Real Sound, which is the online location library that gives unlimited access to Real Scouts, who upload location photos on a rolling basis, which creates opportunities for local small businesses and the Township will obtain film-ready community status recognition in State, press releases, newsletters and social media platforms on the Commission's website. The Township can use the Film Ready New Jersey logo and can get ongoing support and services from the Commission. The Township has commenced working on achieving certification and is identifying locations to be included in the location library and will be submitting at least 15 photos of each location. This could be an interesting opportunity for the Township.

#### Senior Services

Save the Date – October  $13^{th}$  – 10:00am-1:00pm - Health and Wellness Fair will be held at the Senior Center. Flu shots, health screenings and more will be offered.

The Mobile Food Pantry was at the Community Center on July 17th and it was well received. There has been a great turn out. 31 people attended and the remainder of the food was donated to the St. Stephen's Food Bank. The next scheduled date is August 21<sup>st</sup> at 12 noon.

All programs and meals at the Engle Sprague Senior Center are very well attended and attendance continues to increase every month. Please register. All are welcome.

Wellness Speaker Programs and activities are offered after every meal. Please pick up the calendar in the back of the room or on the Township website and Township e-mail for events at the Senior Center. There is a new speaker every week.

Ocean County Congregate Meals. Hot meals are served every Monday and Wednesday. Tuesday there is pizza and a wellness speaker program after the meals. Fulfill of Monmouth County provides a boxed lunch for attendees to eat in or take home every Tuesday. Bingo is held for nominal prizes.

There are many exercise classes and social recreation including Art, Bingo, Cards, Mahjong, Bunco, and other games that everyone is welcome to attend. It is a wonderful way to socialize, meet new people and just be able to be out of the house.

#### Chief of Police - Michal Rogalski

Chief Rogalski read the June 2023 Police Report. The Police Department handled 3,977 incidents for police service, 3 abandoned 911 calls, 27 alarms activated and responded to, 27 animal complaints, 2,284 business/residential checks, 5 acts of criminal mischief, 2 domestic violence incidents, 22 verbal disputes/harassment complaints, 16 disabled vehicles, 7 drunk driving arrests, 1 drug arrest, 95 first aid calls, 26 motor vehicle accidents, 549 motor vehicle stops of which 96 summons were issued, 7 juvenile complaints, 1 local ordinance violation, 5 psychiatric evaluations, 14 persons were arrested on various warrants, 44 suspicious persons and/or vehicles were investigated and 4 thefts from residences or commercial properties and 1 theft from a motor vehicle were investigated. A full list of this activity is on the Township website.

On June  $2^{nd}$  the Police Department graduated the Sixth Grade Class from DARE. This was the first year the Police Department was able to take them on a field trip and went to Urban Air Trampoline Park in Toms River, which was well received. Due to financial issues, the school was not able to provide a class trip this year. By way of fundraising efforts through DARE, we were able to provide them with a field trip for graduation.

The Cone With A Cop event was on June 16<sup>th</sup> at Trailside Gardens. 164 kids attended with their families, which is the largest showing so far.

On July 14<sup>th</sup>, 63 recruits graduated from the 11<sup>th</sup> Annual Junior Police Academy, which was a fantastic week marked with great weather, until graduation.

The good is in the future, the Township will have an owner of the property paying taxes. The taxes have not been paid on that property in over 20 years.
