Timothy Long is sworn in by Attorney Rumpf. Mr. Long is proposing a 6' solid fence to 6" off the property line whereas 10' is required on a corner lot and states there is no hindrance to the sight triangle. Mr. Worth noted that this property has two front yards, one along Fourth Street and one along Seminole Avenue. Mr. Worth also advised the board that the township had revised the ordinance for properties with two (2) front yards to allow for fences to be within the front yard setback that is opposite the main, which in this case would be on Seminole Avenue. Mr. Long testified that he is looking to maximize the backyard area as well as provide additional privacy and safety for his family as many people walk along Seminole Avenue. Mr. Long advised that drivers tend to make a rolling stop at the Fourth Street intersection where he believes that having the fence may deter that action by drivers and encourage a full stop. Mr. Long testified that other properties in the neighborhood also have fences and this would coincide with the look of the area. Mr. Worth noted that there would still be at least a 10' buffer from the curb line with the fence being 6" off the property line with the right-of-way included.
