#### **Committee Reports**

Mayor – Dennis F. Tredy

## American Legion – Post 518 – Lacey Township

The American Legion Post 518 contacted the Police Department and requested to play taps and honor the Dallas Police Officers by reading their names and playing taps at sunset. All of the Township's first responders were given the information. They also played taps for Police Officers who had passed away and were veterans.

The Waretown Volunteer Fire Department, Waretown Volunteer First Aid and the Township Committee attended this heartwarming event. Thank you – American Legion Post 518.

#### 1. Bond Ordinance 2016-9

This bond ordinance is to finish the work at the water treatment plants. This project includes new flow meters and valve actuators and a new chlorine contact tank. The water treatment plants, as well as other areas of the water and sewer system in the Township, are aging and need updating.

## 2. NJEIT Project Bayshore/11th Street/Seneca/Skipper's Cove

This project is almost complete. All milling and paving is complete. Outstanding punch list items are being handled at this time.

# 3. OT – Municipal Aide Program

The 2014 Pocahontas Avenue & 2015 Oregon Avenue projects are now complete and punch list items are being attended to at this time.

## 4. DOT – Municipal Aide Program -2016 - Sheridan

This project is now on hold as per the state mandate.

#### **5. Resolution 2016-291**

The Township will be renewing its contract with Stewart Business Systems, providing copier and printer services. The contract has a cost savings to the Township. The contract includes upgrading the copiers, all service calls, toner, and supplies.

#### **6. Resolution 2016-299**

Appointing a seasonal laborer to the Department of Public Works. An employee had resigned and another is out on disability at this time. This is a very busy time for the Department of Public Works. He is a part-time seasonal employee who is paid only for hours worked and is not entitled to any benefits.

#### 7. Resolutions 2016-304 – Garbage contract – extensions

The Township of Ocean is out for a joint contract with Barnegat Township for garbage and recycling. The Township did this 5 years ago and both Townships benefited financially. The strength in numbers of homes seemed to assist both Townships. The bids have been advertised to be returned on August 24, 2016. The contract will be awarded at that time.

#### 8. Town Wide Yard Sale – July 23, 2016 – 8:00 am – 2:00 pm

At this time there are over 70 homes registered. Thirty-two (32) spots are reserved at the Waretown Lake Park, which includes Greenbriar residents. Holiday Harbor is allowing their members to bring items to the beach club. This will also be on the map.

## **Court - Resolution 2016-294**

The Court Administrator, Debbie Wight, retired on June 30, 2016 after 34 years of service. Steve Millette has worked as the Deputy Court Administrator in the Township for almost 6 years and has obtained his Court Administrator Certification. After consideration by the Ocean County Municipal Court Division and the approval of Judge Ford, Steve Millette will be appointed as Court Administrator.

## Finance Resolutions - 2016-311, 2016-312, 2016-313, 2016-314

Resolution 2016-288, authorizes the acceptance of the 2015 Municipal Audit. Required by state law, every municipality must be audited every year. The Township has secured a clean audit that does not have any exceptions.

There are several Resolutions on the agenda tonight authorizing the insertion of an item of revenue to the 2016 budget. When the Township is awarded grant money or funding it needs to be added to the budget by resolution. Tonight there is a total amount of \$43,150 of grant funding to be placed in the budget.

## Police Department – Resolutions 2016-305, 2016-306, 2016-307, 2016-309, 2016-311

Tonight there are several Resolutions referencing the Police Department. The Township Committee is officially appointing Lt. George Thompson as the Office in Charge of the Police Department and Accreditation Manager.

The Township Committee, in working with the Police Department, is moving forward to have the Police Department accredited. More than two-thirds of all law enforcement agencies in New Jersey are accredited.

Accreditation is a time-proven way of helping law enforcement agencies calculate and improve their overall performances. The foundation of accreditation lies in the adoption of standards containing a clear statement of professional objective.

On the agenda tonight is a Resolution authorizing the Rodgers Group, LLC to assist in meeting the goal of becoming accredited.

The Township is working with the Ocean County Joint Insurance Fund regarding a grant for funding this project. The Ocean County JIF encourages all departments to pursue accreditation.

Also, on the agenda tonight is a grant from the Attorney General's office to fund the Cops in Shops program. This program monitors adults that may be trying to purchasing liquor for underage children and underage children trying to purchase liquor illegally. Usually an officer is inside the building or somewhere outside monitoring such behavior.

# 1. Clean Up Weekend- Environmental Commission

The Township of Ocean Environmental Commission held its 14<sup>th</sup> Annual Town Wide Clean Up Weekend on Friday, June 17<sup>th</sup> and Saturday June 18<sup>th</sup> at the Waretown Lake and Recreational Area. Approximately 1,000 vehicles attended the event. A summary of the items collected were 14 bins of paint cans, 625 gallons of oil, 50 gallons of antifreeze, 17.46 tons on concrete, 106 pounds of batteries, 5 containers of metal, 6.11 containers of brush and stumps and 82.6 tons of garbage. Compared to 2015 there was less paint, oil, concrete, brush, and garbage.

This event was again a great success and assists the Township in minimizing illegal dumping down and is funded through the Clean Communities Grant.

#### 2. Resolutions 2016-295, 2016-296, 2016-297

These resolutions relate to property maintenance liens, which does not abate the violations assessed by the Code Enforcement Officer. At that time the Department of Public Works will bring the property into compliance. This does not release the property owners from fines and penalties incurred by the violations.

#### 3. Municipal Alliance

The Fishing & Crab Contest was held for the first time at Sands Point Park. No fish were caught but a total of 44 crabs were caught in the 1½ hour event. Every participant left with a small prize. The people and children who attended enjoyed the event.

The Township Committee would like to thank Creekside Fishery for donating 10% off gift certificates to all participants, crab traps, lines and lures and Spencer's Marina who gave 4 fishing poles and bait hooks.

Summer programs are going well and registration is great for Summer Camp and Golf Camp.

The Township bus trips that are scheduled from now until the beginning of October are filling up. Ellis Island Trip is sold out and the Jets football game is sold out. The Bronx Zoo, Taj Mahal Casino and Peddler's Village still have available seats.

The Township has commenced a bulkhead replacement project at the end of Bonita Road that began earlier this week and is 1-2 days from completion.

Eileen Doyle, 243 11<sup>th</sup> Street, inquired if Grand Bay Harbor gets reimbursed for services that the Township would normally provide.

Mayor Tredy discussed yes.

Township Administrator Ambrosio discussed by law, the Township has to reimburse condominiums for garbage pickup.

Mrs. Doyle discussed the riders are very appreciative of the Township's Ocean County Mall bus trips. However, the riders inquired if the bus could go somewhere else on the 3<sup>rd</sup> Friday of every other month, when Oceanride goes to the Ocean County Mall, so they don't have to go to mall twice in one week. Suggestions are bus trips to the Freehold Mall or Hamilton Mall.

Township Administrator Ambrosio discussed working out a schedule with the Recreation Coordinator.
