Committee Reports

Mayor – Dennis F. Tredy

Resolution 2016-354. The Township has sold items that have out lived their useful life, no longer work, etc. For the last sale of items that were auctioned, the total amount paid to the Township was \$26,121.10.

NJEIT Project 2016. The project for drainage and water/sewer upgrades in Pebble Beach is scheduled to start this week.

Property Liens to abate Violations. Resolutions 2016-350, 2016-351, 2016-359, 2016-360. These resolutions place liens on properties that the Township had to go out and abate.

Resolution 2016–363 DOT Municipal Aid 2014/2015. This resolution authorizes Change Order #1, which will decreases the overall cost of the project by 6.13%. This will close out these two projects. There are still restoration items on the punch list that need to be completed and the maintenance bond has been submitted for review by the Township Attorney.

Deputy Mayor - Tina Wetter

Tax/Water Resolutions – 2016-345, 2016-346, 2016-347, 2016-348, 2016-353. On tonight's agenda are several resolutions that are for overpayment of taxes and water/sewer bills. All refunds due to overpayment, usually from the mortgage companies or lienholders, need to be handled by Resolution.

Police Department. The Police Department is continuing moving forward with the Accreditation process. Lt. Thompson has had several meetings with The Rodgers Group. This will continue throughout the process. The Department has implemented new software to assist with the process and updating information into the future.

A Township Class 2 Officer resigned and the Township will be moving forward to replace this position.

Ordinance 2016-10. The ordinance being introduced tonight is revising Ordinance 2013–3 regarding Chapter 410-8 "Zoning". This ordinance was sent to the Pinelands Commission for their review and comment. The Pineland Commission has requested changes in regards to the conformance with the Pinelands Comprehensive Management Plan. The changes have been made as requested and will be introduced tonight.

Resolution 2016-362. This resolution releases the performance bond for Section 8 in Greenbriar. This was done at the August meeting but after further review the information in the resolution needed to be corrected. This is being completed tonight.

Resolution 2016-349. There are two openings on the Planning Board at this time. One position is being appointed this evening.
