Presentation

Mayor Dennis F. Tredy - Plaque

Resolution 2016-407

Authorizing the promotion of Officer Kevin McKnight from Class II special police officer to full time Police Patrol Officer.

Deputy Mayor Wetter discussed the Township is promoting Kevin McKnight to a full-time patrolman. Kevin grew up in Waretown, served in the US Marine Corp. and soon after applied to be a dispatcher in the Ocean Township Police Department. He started as a part-time dispatcher on February 9, 2016.

Kevin was promoted to Class II police officer, attended Ocean County Police Academy starting August 24, 2015 and graduated May 24, 2016. Kevin received the PTC Merit Award at the Academy graduation.

Kevin has served as an outstanding Class II Police Officer and tonight he will be added to the ranks as a full-time patrolman.

Lt. George Thompson joined Kevin McNight as he is sworn in by Township Administrator/Clerk Ambrosio.

Committee Reports

Deputy Mayor – Tina Wetter

Deputy Mayor Wetter submitted the following report to the Township Clerk, to submit into record:

Ordinance 2016-13 - Community Center - 2nd Reading - Public Hearing

As stated at the last Township meeting, our Community Center has had some issues with the lighting. Due to the age of the building and having to keep the building in working order, there are certain items that need to be replaced. The large meeting room in the front of the building will be refurbished with the purchase of new tables, chairs, ceiling tiles and energy efficient lighting. This project is starting Monday, December 12, 2016. The Township will continue to make improvements to this aging building that is used by so many Township residents and community groups 7 days a week. The fee for the rental will increase from \$50.00 per 5 hour rental to \$100.00 in 2017, \$150.00 in 2018 and 200.00 in 2019 for a five hour rental. Again, this is still the least expensive rental in the area.

Police

Resolution 2016–412, 2016-413, 2016-424

The Police Department has applied for two separate grants. The first grant, Resolution 2016-412, is to approve the Township to enter into a Memorandum of Understanding with the Ocean County Sherriff's Department for the purchase of a Motorola radio in the amount of \$8,000.00.

The second grant is from the State of New Jersey, Homeland Security, Resolution 2016-413. The grant is reviewed by Ocean County and forwarded to the New Jersey Office of Emergency Management Emergency Responders Bureau. The Township rated #1 in this category and was awarded \$9,400.00. The Township has received the letter awarding the funds and a resolution to approve the funding into the budget is listed on the agenda this evening, Resolution 2016-424.

<u>Resolution 2016-418</u> is a resolution authorizing Matthew VanPelt to be promoted from part-time Dispatcher to full-time Dispatcher. This position is being filled because one of our dispatchers has resigned. At this time the Township is advertising for additional part-time dispatchers.

Resolution 2016-420 - Grant - Accreditation

The Township of Ocean has applied for a grant to assist in the payment of the Police Department Accreditation to the Ocean County Joint Insurance Fund. The Township was awarded a 50% matching grant in the amount of \$20,000. This is being placed into the budget as required by NJ Department of Community Affairs.

Committeeman - Dan Collamer

Resolution 2016-411 - Municipal Alliance

This resolution is authorizing the Municipal Alliance grant for 2017 in the amount of \$21,786. This funding is used for specific programs that are allowable under this grant. Some of the funding goes to after school programs in the Waretown School District. This money is also used for assisting programs within the Township of Ocean.

<u>Resolution 2016-410 – 2014/2015 NJ DOT Municipal Aid Program - Improvements to Pocahontas Avenue & Oregon Avenue.</u>

All the work and restoration for these projects are now complete. The final closeout documents have been submitted. The Township received a letter from the State of New Jersey stating that the Township can now submit paperwork that involves the DOT Municipal Aid programs

<u>Resolution 2016-419 – Poplar Street Pump Station Rehabilitation</u> authorizes the Township Engineer to advertise for bids. This is one of the largest pump stations within the Township and is in need of repairs and updating.

Update on Pebble Beach Water & Sewer Main - NJEIT Project

All utility work is completed on Maplewood Road. The contractor has begun the sanitary sewer replacement on Teaneck Road this week. Improvements include a new water main, sanitary sewer main, storm drainage and roadway repaving. The project area includes Englewood Avenue, Dune Lane, Harborage Place, Stillwater Road, Maplewood Road and Teaneck Road.

Water & Sewer

In the Barnegat section of the Township of Ocean sewer and water system, there was a water main break. This main was hit by a contractor working in the area. Due to the large break, the pipe needed to be replaced and Tulsa Drive and Beverly Drive were placed on a boil water restriction for 24 hours. All water test results were received and the boil water restrictions were lifted. The Township was in touch with the Barnegat Township Administration and Police Department the entire time, as it affected their residents. A bill will be sent to the contractor.
