Committee Reports

Committeeman - Lydia M. Dodd

The Rabies Clinic was held on February 9, 2019. During the event 133 dogs and 40 cats received free rabies vaccinations. Town Hall was open for residents to license their pets. On that day 59 dogs and cats were licensed. As of today's date 478 dogs and 104 cats have been licensed in 2019. The totals for 2018 were 860 dogs and 182 cats were licensed. I would like to thank the Board of Health, Southern Regional High School Students and Dr. Andrew Wurst, who volunteered their time to assist in this important event.

Last year the Township instituted a Vacant Property Registration Ordinance (2017-15). The Township has been successful in having the properties pay the fees and register vacant properties. This assists Code Enforcement to have the proper information when a property is not maintained. There were a total of 59 properties registered in 2018. This assists in companies wanting to sell the properties, instead of paying the increasing fees. A letter will be sent to the properties for renewal at the fee of \$2,000 per property.

Update:

The Route 9 bridge work has been completed and the detour has ended. The New Jersey Department of Transportation will continue working on the bridge for approximately a year, again depending on the weather.

Buy Rite Liquors has been demolished. The plans for the new building have been submitted by the owner and are under review at this time.

On Sunday, March 17, 2019, from 2:00 pm-3:30 pm the Historical Society will be giving a presentation on the history of the Garvey and Skiff Building in the Ocean County Area. The speaker will be Bill Irving, Announcer and Spokesman of the New Jersey Speed Garvey Association. Mr. Irving has an easy storytelling style. He will bring models, photos and clippings. Deputy Mayor – Ken Baulderstone

Ordinance 2019-1 – 2nd Reading – Public Hearing. Tonight the Township will have a Public Hearing on the ordinance to create the Economic Development Committee. The ordinance outlines the functions of the Committee. Upon approval of the ordinance tonight and publication, the Township Committee will review the Citizen Leadership forms and will appoint members to the Committee at the March 14th meeting.

Ordinance 2019-2 – 1st Reading – Title Only. The Township Committee will be voting on an ordinance for a Municipal Wildfire Safety Council. This council will coordinate wildfire prevention efforts within the Township. The ordinance outlines the purpose and duties of the council. The second reading, Public Hearing will be on March 14th. Anyone wishing to be considered for the council, will need to submit a Citizen Leadership Form to the Clerk's Office.

Resolution 2019-131 authorizes a leak credit for 8 Reno Drive. This is a section of Barnegat that is part of the Utility Department service area. The leak was on the Township side of the meter.

Resolution 2019-132. Resolution granting preliminary and final utility approvals for Walters Homes Cornerstone at Waretown apartment project. This was previously referred to as the Waretown Family Apartments. Their plans have been reviewed by the Township Engineer. There was a preconstruction meeting on Tuesday regarding the project. Walters received the funding for the project. It consists of 54 low and moderate affordable income housing. This was part of the settlement with the courts regarding the Township's Affordable Housing. They have filed for their tree clearing permit. Once it has been approved the site work will start immediately. The project should take 16 months to complete, weather permitting.

Department of Public Works

The Township's salt shed has been completed. Additional salt has been delivered. This project was completed in-house. The employees did a great job handling this project. Thank you Department of Public Works (DPW). DPW salts on required occasions.

The holiday tree collection is complete. The trees were picked up curbside and chipped. Leaf pick up is complete at this time. Leaf pick up will resume by section starting the week of March 11th. This information is on the Township calendar. A concrete block wall has been added to the leaf bin at the Waretown Lake.

DPW completed emergency water repairs in the Pebble Beach section of town on Seneca Boulevard and Pohatcong Avenue. Sewer pipes have been jetted and cleaned on several streets in Pebble Beach. The storm drain on Bayview Drive has been replaced. DPW also plans to paint the hallway in the Community Center and disconnect the electricity in the old construction trailer.

Recreation/Special Events

The Senior Advisory Committee meeting program on February 25, 2019 will be the Halifax Connection to Titanic presented by Sandy Gray.

Snowman Building Contest. Each entrant must build his or her snowman November 1, 2018 to March 1, 2019. The snowman must be built in the Township. Entry photos must be dropped off at the Clerk's Office or emailed to Jean Broadbent to recreation@twpoceannj.gov by March 2, 2019.

Founder's Day is May 25, 2019. Applications are being accepted for vendors. All forms are on the Township website or can be picked up in Town Hall at the Clerk's Office.

Mayor - Ben LoParo

Resolution 2019-126. This resolution authorizes the Township of Ocean to accept the Emergency Management Agency Assistance Subgrant Program (EMAA). The grant is for a total of \$20,325.25. This is a matching grant. The Township will receive \$10,000 for the purpose to prevent, protect against, respond to and recover from acts of terrorism, natural disasters and other catastrophic events and emergencies. The funds are used to offset the salary of the Office of Emergency Management. Thank you to Chief Rogalski and the Township of Ocean Police Department for securing this grant.

Resolution 2019-127, 128, 129. These resolutions are authorizing the purchase of vehicles for the Police Department. There was an accident involving a police vehicle. Due to the fact that the police cars are a unibody, the car has been declared totaled by the insurance company. The Township will receive approximately \$18,000 towards the vehicle. The Township needs to replace this vehicle. When Chief Rogalski investigated the purchasing of the vehicle, he was informed the vehicle prices would be going up for the 2020 models. Chief Rogalski was able to secure two 2019 vehicles. The Township has been budgeting at a minimum one police vehicle per year. The planning of the vehicles will assure that the Township does not have to bond to purchase several at one time.

Resolution 2019-130. Malyssa Zafonte has completed her training in the dispatch department. Chief Rogalski has recommended that Ms. Zafonte be moved into the full-time position that has been open due to a resignation.

The Southern Regional Rams Wrestling team won the State Championship on Sunday.

Chief of Police – Michal Rogalski

Chief Rogalski read the January 2019 Police Report. The Police Department handled 4,560 calls for police service, 4 abandoned 9-1-1 calls, 36 alarms were activated and responded to, 16 animal complaints were handled, 2,176 business house watch checks, 4 criminal mischief acts were investigated, 20 domestic violence incidents, 15 disabled vehicles were assisted, 2 drunk drivers, 11 drug arrests, 59 first aid calls, 29 general complaints, 23 motor vehicle accidents, 693 motor vehicle stops of which 223 were issued tickets, 2 juvenile complaint, 6 psychiatric evaluations (PESS), 27 persons were arrested on various warrants, 2 shoplifting incidents, 56 suspicious persons and/or vehicles, 7 thefts from residences or commercial properties. A full list of this activity is listed on the website.

During the month of January, officers conducted 117 individual traffic details within the neighborhoods of Ocean Township. Of the 117 details, 43 motor vehicle stops were conducted. Six (6) tickets were issued and 48 warnings. Of the 48 warnings, 36 were speeding warnings.

Ken Fekete, 58 Beacon Drive, inquired if the leadership forms submitted previously will be reviewed for this Committee and what are the qualification for a position.

Deputy Mayor Baulderstone discussed the Township Committee will be reviewing the leadership forms that relate to this specific committee.

Mr. Fekete discussed it was said at a meeting that the prior applications would be kept on file for future opportunities.

Deputy Mayor Baulderstone discussed the form identifies the committees you are interested in. Applicants that have experience and background in commercial real estate and property development are the best qualified for that committee. There are many different aspects of economic development. There are no specific qualifications.

Mayor LoParo discussed the applicant has to be a resident of Waretown.

Eileen Doyle, 243 11th Street, inquired if the vacant property registration is for homes repossessed by a bank and what happens if you do not report it.

Committeewoman Dodd discussed, yes, it is for homes repossessed by banks.

Township Administrator/Clerk Ambrosio discussed the current ordinance is missing the failure to register issue. That is why the ordinance is being amended tonight. New Jersey State Law requires the banks register with the Municipal Clerk. The owner of the property is responsible for registering.

Mrs. Doyle inquired where the Walters Homes Cornerstone project is going to be.

Deputy Mayor Baulderstone discussed the project is going to be immediately south of the newly constructed liquor store.

Mrs. Doyle inquired if the ceiling room could be taped in the Senior Room at the Community Center. It is in bad shape.

Township Administrator/Clerk Ambrosio will have Public Works look at it.

Mrs. Doyle inquired where she can find out about Mr. Mackres' new plan.

Township Administrator/Clerk Ambrosio discussed the project has not been heard at a board at this time.
