Committee Reports

Good evening.

Shredding. The Ocean County Department of Solid Waste has announced the Spring 2024 dates for document shredding. They will be in Waretown on Saturday, May 11, 2024 from 9:00 am – 11:00 am or until the trucks are full. Paper only. Four (4) file boxes for each vehicle – no plastic bags.

Ordinance 2024-4. Tonight, the Township is holding a public hearing on this ordinance, required by the State of New Jersey, regarding stormwater regulations and privately-owned salt storage facilities.

Ordinance 2024-5 & 2024-6. These ordinances being introduced tonight are mandated by the State of New Jersey regarding "Stormwater Control".

Ordinances 2024-8, 2024-9, 2024-10, 2024-11. These ordinances being introduced tonight are bond ordinances for necessary items. 2024-8 is for the New Jersey Department of Transportation improvements. The Township received grant funding in the amount of \$404,340.00. The Township needs to spend the money and request reimbursement. The Township will pay for stormwater updates in the area.

Ordinance 2024-9 is for the replacement of the Pebble Beach Water Treatment Plant that has outlived its useful life. This will update the building, backwash tanks, and computer equipment that is necessary under the Clean Water Act. The Township will be applying for IBANK funding for a low interest loan and loan forgiveness.

Ordinance 2024-10 is for the rehabilitation of the Dock Avenue Pump Station. This is a heavily used station that needs updates and refurbishment.

Ordinance 2024-11 is bonding for the Townshipwide lead service line replacement project. This is an unfunded mandate that the State of New Jersey is requiring each town to handle. The Township will be applying for funding through the IBANK for a low interest loan and loan forgiveness.

March 2024 Construction/Zoning Report

Zoning Department. 53 applications approved, 7 applications pending review and 7 denial applications.

Code Enforcement. 29 Notices of Violation and 8 Abated Violations.

Construction. 67 Construction Permits issued and 40 updates.

Budget Information

Ordinance 2024-7, Resolutions 2024-141, 2024-142, 2024-143. These items are required by the State of New Jersey for the introduction and reading of the 2024 Municipal Budget.

The Budget introduced tonight will be posted on the Township website and the Budget Summary will be published in the Asbury Park Press.

The Township of Ocean was ordered to have a reevaluation of the town. This has been completed. Due to the true market values of homes in Waretown, the overall value of the Township has increased. In 2023 the municipal taxable income was \$10,300,949.46 and now in 2024 the municipal taxable income is \$11,043,384.60.

The municipal tax rate for 2023 was 0.761, now in 2024 the municipal tax rate is 0.482 which is a decrease of the municipal tax rate by .0.279. Due to the true market value of the homes changing, there will be no Municipal Tax increase in 2024.

As with all Reevaluations, homeowners are likely to see 1/3 of the homes will go up, 1/3 of the homes will remain the same and 1/3 of the homes will go down.

The Township of Ocean is always applying for grant funding as well as low-cost loans when having to make improvements and repairs. Last year the Township received a total of grant funding of \$719,581.63. Some examples are equipment for the Volunteer Fire Department for \$31,000 and bulletproof vests for the Police Department for \$5,150. The Township Committee hopes to obtain the same amount of grant funding for 2024. Also, in 2024, the Township will have tax revenue from cannabis sales.

There are annual costs of doing business that go up, including health care costs, salaries, fuel, electric and rates have been increased at the Ocean County Landfill. This year the Garbage and Recycling contract increased \$150,000. The Township is paying for ambulance services, Monday through Friday, from 6:00 am to 6:00 pm at approximately \$240,000 for the year.

The Township's Ocean County Joint Insurance fund, which also handles the Township's Workman's Compensation plan, has increased but the Township worked diligently to update all areas of cyber security to obtain a discount. The Township has additional funding coming in from cellular carriers on Township property.

The Township is reviewing all items in the Water & Sewer Department to continue to plan for the maintenance of the pipes, pump stations and comply with the Clean Water Act. Also, all of the unfunded mandates sent from Trenton to the municipalities must be complied with.

The budget being introduced represents a remarkable job of balancing the needs of sustaining a professional municipal operation versus the financial realities of our taxpayers. It is a delicate balance between the two, but I firmly believe we have struck that balance with the budget being introduced.

Resolution 2024-146. Due to Louis (Rico) Fisher retiring April 30, 2024, the Township is hiring a Construction Official, Martin Tellekamp. This is an agreement for 4 years. Martin will also remain as the Plumbing Subcode Official.

Ordinance 2024-12. Tonight is the first reading of this ordinance. The 2nd Reading Public Hearing will be on May 21, 2024. This ordinance is updating the minimum parking requirements. This will assist small businesses with meeting the parking requirements without having to go in front of the Board for a waiver or variance.

Resolution 2024-147. This resolution is appointing Marie Learning, School Board Member, to the Planning Board. Welcome Marie.
