AN ORDINANCE OF THE TOWNSHIP OF OCEAN, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING AND SUPPLMENTING CHAPTER 125 OF THE TOWNSHIP CODE ENTITLED "CANNABIS BUSINESSES"

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Ocean, County of Ocean and State of New Jersey, that various sections of Chapter 125 of the Township Code entitled "Cannabis Businesses" is hereby amended and supplemented to read as follows:

- D. **Annual Registration Fee.** Within seven (7) days of receiving notice that an application for a license is granted, The applicant shall pay to the Township the annual registration fee set forth below. The annual registration fee shall be paid on or before the annual re-licensure application for the cannabis establishment. The annual registration fee is nonrefundable.

§125-6. Taxation.

Local transfer and user taxes imposed:

A. Rates

(1) It is hereby established a local transfer tax imposed on transactions that occur within the Township of Ocean between a cannabis business that holds a cannabis cultivator, cannabis manufacturer, cannabis wholesaler, or any combination thereof medical cannabis dispensary, at the following rates:



(a).	cannabis cultivator	2%
(b)	cannabis manufacturers	2%
(c)	cannabis wholesaler	1%
(d)	medical cannabis dispensary	2%
(e)	cannabis retailer	2%

- (2) It is hereby established a local user tax imposed on non-sale transactions that occur within the Township of Ocean between a cannabis business that holds a cannabis cultivator, cannabis manufacturer, cannabis wholesaler, or any combination thereof, or medical cannabis dispensary, at the following rates:
 - (a). User Tax for cannabis cultivator 2%
 (b) User Tax for cannabis manufacturers 2%
 (c) User Tax for cannabis wholesaler 1%
 (d) User Tax for medical cannabis dispensary 2%
 (e) User Tax for cannabis retailer 2%
