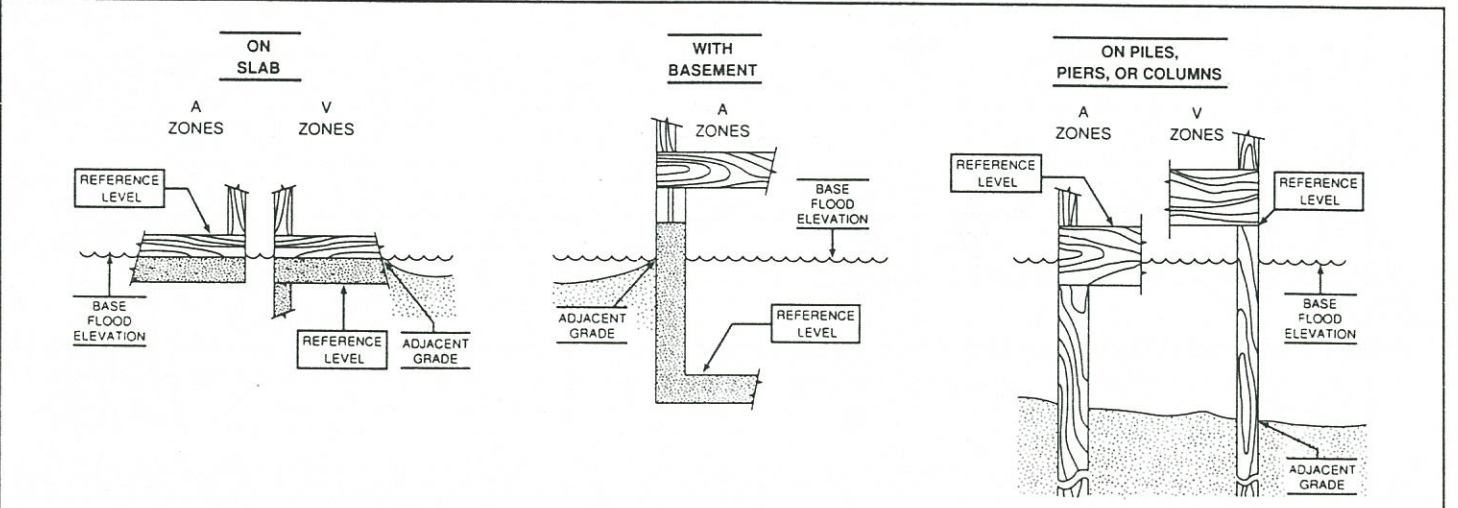

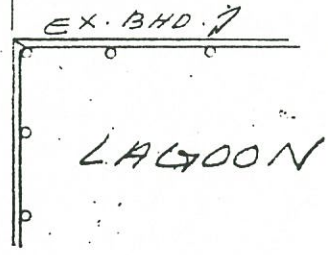
LAGOON VIEW ROAD (50')
