

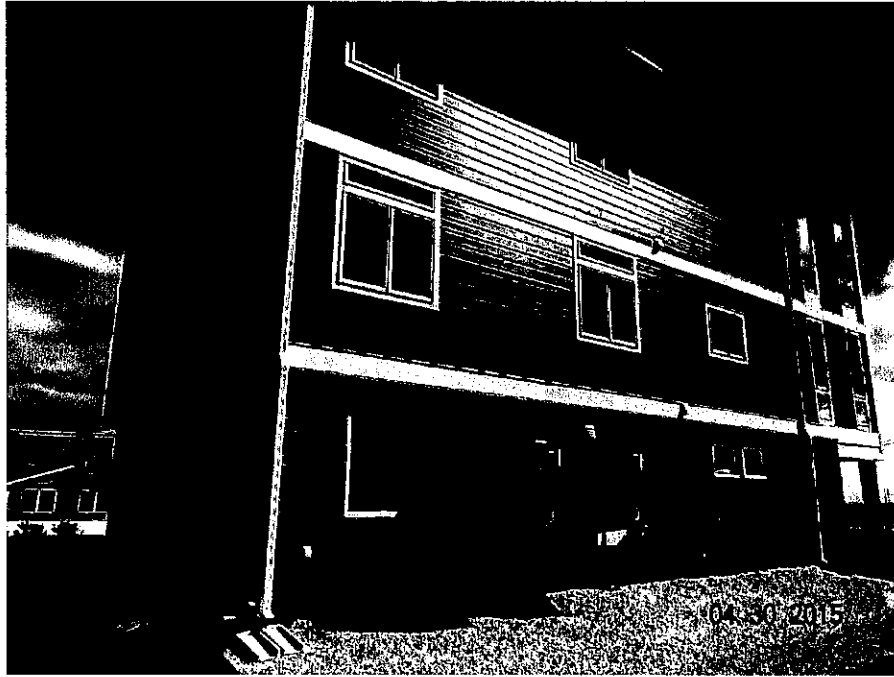
Front View
