**User Fees** - Tournaments shall be charged at the rate of \$500.00 per day for exclusive use of the field. Said fee shall be paid in full 10 days prior to the event. If the event is cancelled 5 days or less prior to the event, the Township shall retain 1-day's fee (\$500.00) as a cancellation fee.

A nonprofit organization or organized baseball or softball league that is exclusive to residents of the Township of Ocean and/or 51% of its membership are residents of the Township of Ocean, shall only be required to pay a one-time fee of \$500.00 for exclusive use of the field. Said fee shall be paid in full 10 days prior to the event. If the event is cancelled 5 days or less prior to the event, the Township will retain the one-time fee of \$500.00 as a cancellation fee.

A security deposit is required in the amount of \$500.00 for any such event or rental.

**Insurance** - Any person, corporation or entity wishing to utilize the Tuomey Park baseball field and/or Railroad Avenue baseball field for exclusive use, tournament use, or by a league, will be required to present a certificate of liability insurance indicating that the person or entity applying for the use of the field has obtained personal and/or entity liability insurance in an amount equal to at least \$500,000 per loss for general liability. Such a certificate must name the Township as an additional insured. Approval for the use of the field shall not be completed until such time as a copy of the Certificate of Insurance has been provided to the Township.
